Once we've received your application we will contact you to discuss the installation and arrange to get you online.

Please note that F4RN is a "not for profit" Community Benefit Society run by volunteers from the local community. We will arrange for the fibre to be brought to the property boundary and will complete the final connection in the property, however as we really on volunteers we do need you to lay the ducting for the fibre across your property. We will provide all the materials and explain what needs to be done but it basically involves digging a shallow trench from our connection point at the property boundary to the external wall where the fibre will enter the property.

We know that not everyone will have the muscle to do this and we will offer support where it is needed if this is an issue.
